## How to Read Your Annual Statement

*Enclosed with this issue of SERS Update is your Member Annual Statement.*

Your annual statement contains the status of your SERS retirement account as of June 30, 2015. It shows your total service credit and the amount you have in your account.

This is the third annual statement you have received that reflects changes resulting from the passage of SERS' pension reform bill in 2012.

While pension reform did not affect your service credit or the amount of contributions in your account, it did affect the age at which you can retire and the amount of service credit you need to retire.

Due to pension reform, if you do not retire before Aug. 1, 2017, there are some age/service combinations where working longer may not be the best financial decision for you.

On this statement, you see three retirement projections. The first one is your earliest retirement eligibility. The next one is your earliest retirement eligibility, plus one year of work. The last one is your earliest retirement eligibility, plus two years of work.

We have given you estimated projections so you can see how the pension reform changes will affect your pension in these three different situations.

Call us to discuss your retirement options if you:

- have service credit with another Ohio public retirement system
- want to buy service credit for time worked in another public-service job
- want to continue working more than two years past your earliest eligibility date
- are concerned about the cost of health care

## New Law for Refunds and Portability

A bill that maintained joint retirement options for Ohio's public employees was passed by the Ohio House and Senate, and recently signed into law.

The law ensures that Ohio's public employees have the ability to combine the service credit they earned from Ohio Public Employees Retirement System (OPERS), State Teachers Retirement System of Ohio (STRS), and SERS, into one meaningful retirement benefit.

The law also allows SERS members who are also members of OPERS or STRS Ohio to refund contributions from an inactive system in certain situations.

Members may receive a refund of their SERS account if they have terminated their SERS-covered position, and at least three months have passed since their last date of service. If a SERS member also is a member of STRS and/or OPERS, the member has the option to refund the SERS account without affecting membership or rights to either a benefit or refund of contributions under those systems.

SERS members cannot refund their account if they continue employment under either of the other systems with the same public employer where their last SERS service was earned.

If the SERS member does not take a refund of the account, the member may combine service credit and contributions in all the systems for a single retirement allowance.

## Same-Sex Marriage Recognized

To comply with the U.S. Supreme Court decision in *Obergefell v. Hodges*, the Board approved a new rule recognizing same-sex marriages, including those performed before June 26, 2015, in states that already recognized them.

Retirees who had a lawful same-sex marriage before June 26, 2015, now have an opportunity to change from a single-life plan of payment to a joint-life plan of payment with the same-sex spouse as beneficiary. This opportunity is for one year and ends June 27, 2016.

A special health care enrollment period, which runs through Nov. 30, 2015, has been set for same-sex couples married prior to June 26, 2015. Benefit recipients who previously have waived SERS' health care coverage can enroll themselves and their same-sex spouses, and those already enrolled can enroll same-sex spouses. ■

## Remote Counseling Sessions

Our Remote Counseling Program offers members close to retirement the opportunity to meet with SERS' counselors without having to travel to Columbus. Instead, counseling is available at various locations around the state, with each individual session providing one-on-one attention as well as assistance in completing the retirement application.

If you would like to attend a Remote Counseling session, make sure we have your current email address so that we can send you email invites. When you set up an online account, you will be able to receive communications from SERS, review your service credit, and run pension estimates.
