




Technology Roadmap – Infrastructure Projects



Technology Roadmap Delivery Methodology






SERS Agile Teams (SAT)



Release to identified Pension Agency Executives

RE: News from Sagitec

Hello Richard, Karen, and Jay,

I write today to share some news about Sagitec that, while not directly affecting our work with you, nonetheless merits notice.

On August 23rd, we learned that two of the leaders of our Labor and Employment line of business, David Minkkinen and Siva Sambasivam, have been indicted on allegations concerning the theft of intellectual property.

The indictments arise from a government investigation in which we have fully cooperated. We expect a final resolution of the matter in the near future, and we will give you further details when that occurs.

In the meantime, I want to emphasize that:

- Sagitec was not indicted.
- The government's investigation does not relate to our pension practice.
- In particular, our Neospin[™] product and our underlying Platform and Framework are not a part of this investigation.
- There is no indication that any other Sagitec employee is a target of the government's investigators.

We remain fully committed to our core values including achieving business results in an ethical and honest manner. In support of that commitment, we have further enhanced our compliance programs and will not tolerate conduct that falls short of our policies and values. Most importantly, we are committed to continuing to fulfill our commitments to you: Sagitec will be a reliable partner to you now and in the future.

As you might imagine, our ability to make further comments on this matter is limited, but I wanted you to be aware of this situation and to give you my assurance that our relationship with you and our ability to serve you is undiminished. We would be happy to schedule a meeting with you to talk about this matter and answer any questions you may have about it.
